OFFICIAL RULES: MORRIS SMITH FORD OF LARNED 2026 FORD RANGER XLT GIVEAWAY

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. SPONSOR AND ADMINISTRATOR

The 2026 Ford Ranger XLT Giveaway (the "Sweepstakes") is sponsored and administered solely by Morris Smith Ford of Larned, located at 820 Fort Larned Avenue, Larned, Kansas 67550 (the "Sponsor").

2. ELIGIBILITY

The Sweepstakes is open only to legal residents of the United States who are eighteen (18) years of age or older at the time of entry and who physically reside within a forty-five (45) mile radius of Morris Smith Ford of Larned. For the purposes of this Sweepstakes, eligibility is strictly limited to residents whose primary physical address is located within one of the following authorized ZIP codes: 67021, 67054, 67059, 67427, 67511, 67512, 67514, 67516, 67519, 67520, 67523, 67524, 67525, 67526, 67527, 67529, 67530, 67544, 67545, 67547, 67548, 67550, 67552, 67553, 67557, 67559, 67563, 67564, 67565, 67567, 67573, 67574, 67575, 67576, 67578, 67849, 67854, and 67876. Employees of Morris Smith Auto Group, its affiliated dealerships, advertising and promotional agencies, participating sponsors, and their immediate family members (spouse, parents, siblings, and children) and/or those living in the same household of each are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

3. SWEEPSTAKES PERIOD

The entry period begins on August 1, 2026, at the opening of normal business hours, and ends on December 14, 2026, at the close of normal business hours (the "Sweepstakes Period").

4. HOW TO ENTER

There is a strict maximum limit of **fifteen (15) entries per person, per household, and per family**, regardless of the method of entry used. Entries exceeding this limit will be disqualified. Eligible individuals may enter the Sweepstakes through any combination of the following methods:

- **Standard Transactional Entry:** Customers who complete a qualifying transaction at Morris Smith Ford of Larned during the Sweepstakes Period will receive entry forms based on the transaction type. The transaction must be officially recorded in the Dealership Management System (DMS).
 - Quick Lane service transaction: One (1) entry
 - Main Shop service repair order: Two (2) entries
 - Parts Department purchase (minimum \$25 spend): One (1) entry
 - Selling a vehicle to the dealership: Three (3) entries
 - Purchasing a vehicle from the dealership: Five (5) entries
- **Community Event Participation:** Individuals who actively participate in company-

sponsored community events at the dealership during the Sweepstakes Period (e.g., decorating a vehicle for Trunk or Treat, donating a turkey during the Turkey Drive, or donating goods during the Canned Food Drive) will receive one (1) entry per event.

- **Alternate Method of Entry (No Purchase Necessary):** Individuals may enter without completing a transaction or event participation by visiting Morris Smith Ford of Larned in person at 820 Fort Larned Avenue, Larned, KS. Entrants must request an official free entry form from the reception desk, fill it out completely, and physically submit it.

Submission of Entries: All entries, regardless of the method earned, must be physically filled out on an official registration card and placed by the entrant into the designated, locked acrylic drawing box located on the dealership premises prior to the close of the Sweepstakes Period.

5. THE PRIZE AND APPROXIMATE RETAIL VALUE (ARV)

One (1) Grand Prize will be awarded. The Grand Prize consists of a 24-month one-pay lease of a commercially wrapped 2026 Ford Ranger XLT.

- **Prize Value:** The Total Approximate Retail Value (ARV) of the prize is \$18,240.
- **Lease Execution:** The Sponsor will remit a single, upfront payment to Ford Motor Credit Company covering the full 24-month term of the lease, including upfront sales and use taxes and a Lease Wear Care protection package.
- **Winner Financial Responsibilities:** The winner assumes total financial responsibility for all other ownership and operational costs, including but not limited to: personal property taxes, comprehensive auto insurance, standard mechanical maintenance (e.g., oil changes, brakes, tires), fuel, and any mileage overage fees assessed by Ford Motor Credit Company at lease turn-in.

6. CREDIT QUALIFICATION AND PARKING VERIFICATION

To claim the prize, the selected winner must meet the following upfront requirements:

- **Credit Approval:** The winner must formally apply and pass standard credit underwriting approval through Ford Motor Credit Company. The vehicle must be leased and registered strictly in the designated winner's name.
- **Parking Verification:** The winner must verify that their primary residence is not subject to Homeowners Association (HOA) rules, neighborhood covenants, or municipal ordinances that prohibit the parking of commercially wrapped or advertising vehicles. If such restrictions exist, the winner must secure alternative compliant parking at their own expense or decline the prize.

7. PROMOTIONAL VEHICLE WRAP AGREEMENT

The prize vehicle will be fully wrapped in Morris Smith Ford promotional branding. By accepting the prize, the winner agrees to execute a separate Promotional Vehicle Agreement containing the following stipulations:

- **Wrap Retention & Penalty:** The vehicle must remain fully wrapped in like-new condition (minus normal wear and tear) for the entire 24-month lease. If the winner removes, covers, or intentionally damages the wrap prior to the end of the lease, the winner is legally liable to pay the Sponsor a prorated lease reimbursement penalty based on the remaining months of the lease value.
- **Accidents and Repairs:** If the vehicle requires auto body repairs due to a collision or damage, the winner (or their insurance company) is financially responsible for the cost of re-wrapping the repaired sections to restore the promotional branding. All accidents must

be reported to the Sponsor immediately.

- **Month-23 Return & Paint Liability:** The winner must return the vehicle to Morris Smith Ford of Larned during the 23rd month of the lease. The Sponsor will professionally remove the wrap and detail the vehicle at the Sponsor's expense prior to the final lease turn-in. The Sponsor assumes full liability for any wrap-related paint damage or clear-coat peeling that occurs strictly during this professional removal process.

8. WINNER SELECTION AND NOTIFICATION

The Grand Prize drawing will be conducted publicly at Morris Smith Ford of Larned on December 18, 2026. One (1) winner will be selected at random from all eligible entries received. The odds of winning depend entirely on the total number of eligible entries in the drawing box. The winner does not need to be physically present at the drawing to win.

- **Verification & Proof of Residency:** The potential winner will be notified via the contact information provided on the entry card. The winner must present a valid, state-issued identification and complete all verification and lease documentation within 45 days of the drawing. If the address listed on the state-issued identification does not fall within one of the eligible ZIP codes outlined in Section 2, the potential winner must provide a secondary, official document to verify their current physical residency. Acceptable secondary documents must be in the winner's name, display an eligible physical street address (no P.O. Boxes), and be dated within sixty (60) days of the drawing date. Acceptable documents are strictly limited to: a residential utility bill (water, gas, electric, or trash), a current bank statement, a valid residential lease agreement, or a current mortgage statement. If the winner cannot be contacted, fails to qualify for the lease, cannot prove eligible physical residency, or declines the prize, an alternate winner may be selected.

9. TAXES

The ARV of the prize (\$18,240) exceeds the IRS threshold for prize reporting. The Sponsor will issue an IRS Form 1099-MISC to the winner for the ARV of the prize for the tax year in which the prize is awarded. All federal, state, and local income taxes associated with the acceptance of the prize are the sole responsibility of the winner.

10. GENERAL LIABILITY RELEASE

By participating, entrants agree to release, discharge, and hold harmless Morris Smith Auto Group, Morris Smith Ford of Larned, Ford Motor Credit Company, participating agencies, and their respective officers, directors, employees, and agents from any and all liability, claims, or damages arising out of their participation in the Sweepstakes or the acceptance, use, or misuse of the Grand Prize. The Sponsor is not responsible for typographical errors, lost, late, damaged, or misdirected entries, or any mechanical failures of the drawing box or entry materials.
